## Clinical Policy: Sodium Dichloroacetate (SL-1009)

### Description

Sodium dichloroacetate (Brand Name<sup>®/TM</sup>) is an inhibitor of pyruvate dehydrogenase kinase.

### FDA Approved Indication(s) [**Pending**]

SL-1009 is indicated for the treatment of pyruvate dehydrogenase complex deficiency (PDCD).

### Policy/Criteria

*Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.*

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that SL-1009 is **medically necessary** when the following criteria are met:

#### I. Initial Approval Criteria\*

*\*Criteria will mirror the clinical information from the prescribing information once FDA-approved*

##### A. Pyruvate Dehydrogenase Complex Deficiency (must meet all):

1. Diagnosis of PDCD confirmed by the presence of clinical or metabolic features of PDCD and one of the following (a or b; *see Appendix D*):\*
  - a. Known pathogenic mutation of a gene that is specifically associated with PDCD;
  - b. Both of the following (i and ii):
    - i. A variant of uncertain significance for a mutation in a gene that is specifically associated with PDCD;
    - ii. Enzyme assay demonstrating a deficiency of pyruvate dehydrogenase complex activity;
2. Prescribed by or in consultation with an endocrinologist, geneticist, neurologist, pediatrician, or metabolic disease specialist;\*
3. Age  $\leq$  17 years;\*
4. Member is currently on a ketogenic diet (i.e., a high fat, low carbohydrate diet) and will continue this diet during treatment with SL-1009;\*
5. Dose does not exceed the FDA-approved maximum dose.\*

**Approval duration: 6 months**

**B. Other diagnoses/indications (must meet 1 or 2):**

1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
  - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

**II. Continued Therapy\***

*\*Criteria will mirror the clinical information from the prescribing information once FDA-approved*

**A. Pyruvate Dehydrogenase Complex Deficiency (must meet all):**

1. Member meets one of the following (a or b):
  - a. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
  - b. Member is currently receiving medication and is enrolled in a state and product with continuity of care regulations (*refer to state specific addendums for CC.PHARM.03A and CC.PHARM.03B*);
2. Member is responding positively to therapy;\*
3. Member is currently on a ketogenic diet and will continue this diet during treatment with SL-1009;\*
4. If request is for a dose increase, new dose does not exceed the FDA-approved maximum dose.\*

**Approval duration: 12 months**

**B. Other diagnoses/indications (must meet 1 or 2):**

1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
  - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or

2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

**III. Diagnoses/Indications for which coverage is NOT authorized:**

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid or evidence of coverage documents.

<i>PDHA1</i>	Pyruvate dehydrogenase E1-alpha deficiency
<i>PDHB</i>	Pyruvate dehydrogenase E1-beta deficiency
<i>DLAT</i>	Pyruvate dehydrogenase E2 deficiency
<i>PDHX</i>	Pyruvate dehydrogenase E3-binding protein deficiency
<i>PDPI</i>	Pyruvate dehydrogenase phosphatase deficiency

- Clinical and metabolic features of PDCD include, but are not limited to:
  - Metabolic: elevated lactate, elevated pyruvate, elevated plasma alanine and proline, metabolic acidosis
  - Neurologic: seizures, developmental delay, hypotonia, ataxia, gait disturbance
  - Facial features: long philtrum, thin upper lip, and low-set ears
  - Growth: intrauterine growth restriction, microcephaly
  - Musculoskeletal: hip dysplasia
